## **Report of Arbitrators**

Lawrence, Mass., April 15<sup>th</sup> 1911

Henry F. Lea Esq., Methuen Water Board Methuen, Mass.

Dear Sir:-

In accordance with your request as authorized by the Methuen Water Board by its vote of August 5<sup>th</sup>, 1910, we beg to submit the following report in relation to the damages sustained by the Methuen Company in consequence of the diversion of a portion of waters of the Spicket River for a domestic supply for the Town of Methuen. There were two questions to be settled. The first was the period from the date of the writ, April 1<sup>st</sup> 1907, to the present time, and second the amount which should be paid for the rights for future use.

From the data furnished by the Superintendent of the Water Board relating to the amount of water pumped at the station, we find that the loss, from date of writ, April 1<sup>st</sup>, 1907, to July 31<sup>st</sup>, 1910 to be \$324.00.

For the second question regarding the compensation in settlement for future use, we have considered that from a study of the growth of population, and increase in the use of water it was reasonable to provide for an amount of 1 cubic foot per second or 236,000,000 gallons per year. The population is about 11,500 by the last official census in 1910 and the amount provided for may be sufficient for 30 years or possibly the amount may be reached at an earlier date. The consumption in July, which is a dry month, reached nearly 19,000,000 gallons which at this rate would nearly reach the limit. The other months indicated a much less amount of use.

In considering the loss of power sustained by Methuen Company we conclude that as compensation for the right to draw 1 cubic foot per second throughout the year or 236,000,000 gallons total yearly, the Town of Methuen should pay the Methuen Company the sum of \$1950.00 and that when the limit of this quantity is reached a new agreement, and if necessary, readjustment of rates, should be made for this increased quantity. In the proposed agreement it has been provided that a quantity not exceeding 50 per cent in excess of the average quantity per month may be drawn during any one month, to allow a flexibility in its use which is liable to vary at different seasons of the year.

It is also understood that in the event of such condition as a large conflagration, requiring a large amount of water, that this amount of 50 per cent may be exceeded if necessary. To avoid any misunderstanding it is recommended that an Indenture between the two parties be executed and recorded in the Registry of Deeds for this district.

Such a form is presented which embraces the various provisions and defines the conditions which should be carried out.
