8. The Office of the District Attorney will now review your submitted registration request. If you have questions or feel there is a delay in processing please contact the District Attorney's office in which you have registered.

If your registration request is denied for any reason, you will receive an email back with notes indicating why the account request was denied by the District Attorney's Office.

When your registration account is approved by the Office of the District Attorney you will
receive an email indicating you have been approved and can now login using your email (login)
and your password. Congratulations, you are now registered and authorized for Criminal
eDiscovery.

Create Representative Accounts

Once approved and logged into the website you can choose to set up Administrative Accounts for your legal team to also access discovery and receive notifications on your behalf.

3. Email notification will be sent to you confirming the representative account. This email will include a **PIN** number that you will need to provide to the representative for their initial log on to the website. This provides an additional layer of security for authorization.



4. Representative will receive an email to log into the website with a temporary password, when they log in they will receive the secondary screen requiring the PIN # entry. Representative will enter this PIN (one time only). The representative will now be able to login and obtain discovery on your behalf. The receipts will capture the user logging in for reporting when the discovery was obtained and when/who downloaded the materials for you.

PLEASE NOTIFY THE PROSECUTING ATTORNEY ON YOUR CASE IMMEDIATELY

This letter should also serve as notice to you that all reasonable efforts will be made to allow you reasonable and prompt review of the People's discovery and any tangible objects held in connection with this case. Within the discovery in most cases are reports or "logs" relating to evidence held by the investigating law enforcement agency or agencies. Please review the evidence report(s) provided in your case to be certain you are aware of what is being held and to request additional access to that evidence if you so desire

Through early and consistent communication with the District Attorney's Office regarding any discovery concerns you may have, we hope to be able to resolve matters in a manner that ensures compliance with Crim. P. 16 and applicable case law
