# **Course Description:**

This course is designed to equip students with an understanding of the International Phonetic Alphabet, in addition to the rules associated with the authentic execution of the German language pertaining to lyric diction. Students will demonstrate their knowledge of the International Phonetic Alphabet and German lyric diction through written and oral assignments and examinations, in addition to performances of appropriate German repertoire in class throughout the semester.

### **Course Objectives:**

Upon the completion of this course, the student will be able to:

- 1.) Transcribe German text into IPA symbols
- 2.) Accurately read and sing German text with IPA symbols
- 3.) Accurately read German text *without* IPA symbols, relying on the rules of German lyric diction learned throughout the course of the semester
- 4.) Prepare word-by-word translations of German into English using resources discussed in class

# **Classroom Etiquette:**

The majority of our work in class will stem from information in Cheri Montgomery's book. Please bring the book with you to every class. Diction is a complex subject, as it requires an understanding of phonetic sounds in a non-native language. Due to the complexity of the subject's nature, unnecessary or distracting use of electronic devices including tablets, laptops, and cell phones will not be tolerated. Generally, it is requested that you leave your cell phones and laptops in your bag for the duration of the class.

# **Classroom Etiquette on Singing Days:**

On coaching days, singers will be assigned to perform/coach their repertoire in front of their peers. All students are required to attend and actively participate/remain engaged in their colleagues' performances. Please note that this is not a time to complete work for other classes or do work on a computer. It is important that we create an encouraging and supportive environment for in-class performances. Attendance is required at all final in-class performances, not only your individually assigned time.

To insure a smooth operation, have your music neatly arranged in a three-ring binder and ready to go the day of your assigned coaching/performance. # **Grading Criteria:**

Your final grade will be based on the following:

- 1.) Attendance and participation 20% Attendance and participation are required and expected in order to insure the course objectives will be met. One unexcused absence will be permitted. Daily attendance will be taken. Extenuating circumstances must be communicated to the instructor in a timely manner. In the case of absence, it is the student's responsibility to find out what he or she missed.
- 2.) Quizzes 20% Quizzes will be announced in advance and will cover material from class and assigned readings. Quizzes missed due to unexcused absences will not be made up. Arrangements must be made with the instructor in advance to make-up quizzes missed due to extenuating circumstances.
- 3.) In-Class Coachings and Performances 20%
  Each student will be expected to sing in class four times during the semester.
  Two of these will be coachings with the instructor, and two will be graded performances of assigned repertoire. Attendance on performance days is mandatory for all students assigned to sing. In-class coachings and performances missed due to unexcused absences will not be made up.
- 4.) Assignments 30%
  Assignments will include IPA transcriptions, word-by-word translations, and listening assignments.
- 5.) Final Exam 10%

  The final exam will be comprised of two parts: a written portion covering the rules of IPA as well as transcription, and a spoken portion in which the student will read German text.
