TRANSFER OF ENTRIES

NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON MONDAY, AUGUST 30. AFTER THIS TIME, YOU MUST CONTACT THE SUPERINTENDENT ON SITE.

CONFORMATION: Dogs may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is presented to the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging at the show.

JUNIOR SHOWMANSHIP: Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent prior to the start of the class at the show. Correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer must be made to the Superintendent prior to the judging of the class at the show. **OBEDIENCE OR RALLY:** A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

COVID-19 INFORMATION - Exhibitors, judges, volunteers and spectators will be required to comply with all Facility, Local and State mandates in place at the time of the event.

BE PREPARED TO WEAR A MASK IN THE RING IF YOUR JUDGE HAS REQUESTED THAT EXHIBITORS BE MASKED.

The Best Bred by Exhibitor from each breed will then compete for First through Fourth place awards in the Working Group. The First Place winner is also awarded the Best Bred by Exhibitor in Working Group. Judge for Best Bred by Exhibitor in Breed will be as published for the regular classes. Bred by Exhibitor Group judge will be the same as regular group judge.

- Due to SAFETY, there will be NO extension cords for generators run past those setups along the fenceline.
- NO DOGS ALLOWED in children's playgrounds on CBA location. This

 dogs entered.

- No Alcoholic Beverage use allowed.
- WGDCA will exercise every precaution for the safety of the dogs exhibited and it is understood that neither the club nor the management nor the landlord will be responsible for the loss of, damage to or any damage caused by any dog from any cause.
- WGDCA may decline any entries for cause and may refuse to receive or may remove any dog from the show premises on account of disease, viciousness or other cause, & no one shall have any claim or recourse against WGDCA or any officials thereof for such action.
- Except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows, NO DOGS wrongly entered in a class may be transferred to another class. OWNERS ARE RESPONSIBLE FOR ERRORS in any forms, regardless of who may make such errors.
- The show giving Club, the Event Secretary, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

For Obedience & Rally Only: Effective January 2014, AKC requires that clubs refund the entry fee for females in season. A processing fee may be retained by the club (Obedience Regulations, Chapter 1, Section 14). WGDCA will issue a refund of entry fees minus a \$10 processing fee, upon notification IN WRITING from the entrant whose female has come in season after entries have closed. The Trial Secretary must receive the notification at least 30 minutes prior to start of the first class in the trial.

No dogs that are disqualified for aggression will be allowed to enter these shows, nor be allowed to be on the grounds.
