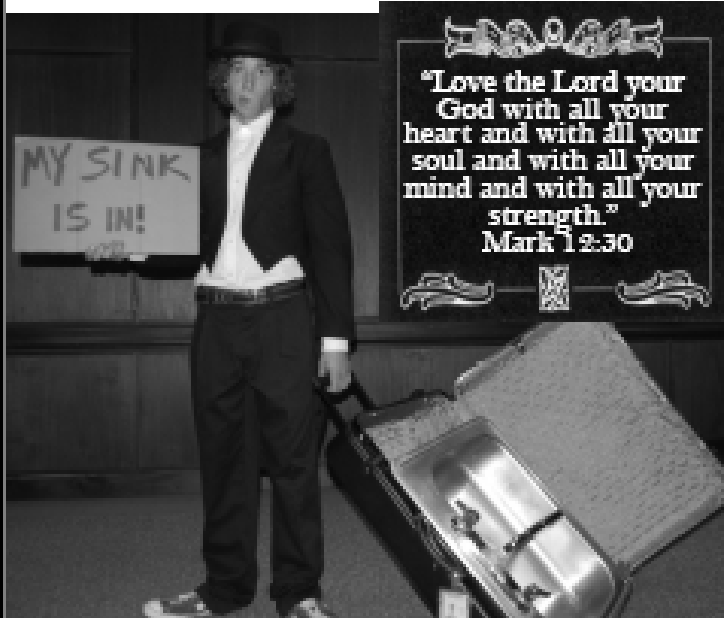

Conference Overview



Rallies

Cutting edge worship with Remedy Drive, student-led prayer, challenging messages about "Loving God with Everything". This year's theme is "My Sink Is In" which focuses on the idea of having students take what they have learned and put it into practice immediately. Our key verse is Mark 12:30, 31 "Love the Lord your God with all your heart, mind, soul and strength and love your neighbor as yourself."

Begin praying now for our speaker, Sean McDowell, as well as Remedy Drive from Nebraska as they lead us in music at each of the rallies as well as hang out with students.

Seminars/ Workshops

We desire students to go deeper in the faith and knowledge of Jesus Christ, so we are offering 16 different seminars and workshops that will encourage them to live out their faith in all areas of their life. Each student and leader is to attend two seminars/ workshops on Saturday from 11:30-12:30 and 6:00-7:00 P.M. A list of all the available seminars/ workshops will be available with the confirmation packets which you can review with your students prior to the conference.

Breakout Sessions

Following each of the rallies, groups will have a time to meet together to discuss and interact with what they just heard. We have a limited number of rooms, so larger groups will be assigned spaces. You may want to check with your hotel about open meeting spaces prior to arriving in Duluth.

Afternoon Options

We will have several options for groups that will include recreation, rainy day movie, and others. We will update you on additional afternoon options with your conference confirmation packet.

Prayer Army/ Team

About 45 minutes prior to each rally, we will have a time set aside for students and leaders that want to commit our rally time to the Lord. This time is spent in large group and small group prayer. We will also have students that will pray for our rallies on stage during each session. Please consider finding someone in your youth ministry that is willing to start a prayer team prior to the conference.

Meals

All groups will be responsible for their own meals while at the conference. Some hotels offer a continental breakfast and some of the hotels also have refrigerators in the guest rooms. There are several fast food locations, however many need transportation. There are grocery stores and many pizza places that are under 2 miles away.

Youth Leader Expectations

The focus of this weekend is ministering to students. We trust leaders will set the example by following conference rules and encouraging their students to do the same. The main leader in your youth group must attend a brief orientation meeting on Friday evening during the first rally. We will also have many of the rules and expectations printed in our conference handbook.

Cost

The cost is \$38 for the conference. \$2 discount per registration for those paying with a check. The cost doesn't include hotel or food during the conference.

Offering Project- We will be taking an offering Saturday night that will go to build wells in Africa. Watch for more details soon.

Location & Directions

All Rallies and Seminars will be held at the Duluth Entertainment Convention Center. The address of the DECC is 350 Harbor Drive, Duluth, MN 55802 and their website is www.decc.org.

Parking/ Transportation

There is plenty of parking in the Duluth area, however parking at the DECC parking lot will be charged a daily parking fee. Many of the hotels are within walking distance, so it would be best to park near your hotel if possible. Contact the hotel for additional free parking information. We are currently negotiating a parking arrangement with the DECC for busses, vans and trailers for a fee of \$5 for each time you enter the lot.

Registration & Payment Instructions

We have enclosed a group registration form and CD/DVD containing copies of all documents for your convenience. If you need to register additional students, include another completed registration form with additional payment.

Health Forms (Leaders Must Have One!) & Medical Personnel

All students and leaders are required to bring a completed copy of the enclosed health form to be turned in at registration. Many of you have your own medical forms, however we do need one specifically for the conference. We will have certified Medical Personnel present at all locations and our largest hotels. In the event of an emergency, it would be best to call 911 or go directly to the hospital.

Ministry Service Projects

The students will have the opportunity to help area churches and ministries in the area, by providing various services for them. More details will be available soon. We will have a 300-500 spots available. All projects will last approximately 1 1/2 hours, including driving time (if driving is necessary).

Head Youth Leader Orientation Meeting

We have a head youth leader orientation meeting scheduled for 8:40 PM on Friday. This will be the time we review the schedule for the weekend and answer questions. We will also have Sean McDowell, our speaker, join us briefly to share what he will be talking to the students about.

Hotel Reservation Instructions

In order to secure housing arrangements for your group here is what you need to do:
