




EdLink 360 Goes Live August 2021


EdLink 360 is the Department's new education data warehouse that revolutionizes the way school systems access and interact with data.

What does EdLink do for school systems:

- simplifies data submissions and login to one platform
- integrates early childhood and K-12 data for a true longitudinal data system
- provides easily accessible data and visualizations for all stakeholders



EdLink Dashboard Updates


EdLink 360 File Processing Dashboards

- File extracts should be uploaded to the PowerSchool sFTP server daily, no later than 7:00pm
- Files are processed and results are available in EdLink 360 by 7:00am the following morning
- EdLink 360 file processing dashboards are available for verifying the results which may include:
 - o file rejection errors errors that prevent the file from being processed
 - e.g. invalid file signature, invalid file name, required columns missing, etc.
 - file record rejection errors errors that prevent the record from being loaded to the data warehouse
 - e.g. data type mismatch, duplicate records, data exceeds defined column length, etc.
 - build audit errors errors that occur when data is loaded to the warehouse but it does not align with business rules to connect it to other data and populate all fields correctly
 - e.g. invalid dates, codes, keys, etc.
 - data quality ADQ checks that are LDOE specific and run after the data has loaded to the data warehouse as they often involve comparing different data points.
 - e.g. US entry date checks, invalid ethnicity/race flags, school with no enrollments,
 LASID does not exist, etc.



EdLink 360 File Processing Dashboards Updates Completed or Under Review

- **All Dashboards:** Continuing to review error messages that are displayed on the dashboards to improve readability and to provide a clearer explanation of what corrective action should be taken (e.g. adding additional information LASID, LOCAL_ID, etc.).
- **File Errors Dashboard** added drill through link on Build Number to bring you directly to the File Record Rejection dashboard.
- **File Record Rejection Dashboard** changed title of Process ID column to Build Number; looking into adding unique key to each record.
- **Data Quality Dashboard** added Audit Code column which should align with the Audit Codes and Error Messages listed in the EdLink 360 user guides.
- **Error Reports** In addition to listing and sorting by error type, looking into providing additional information that can be downloaded and sorted by school for additional research. We will be pulling together a small working group for further feedback on improvements in the dashboards in general.



School Calendar - In progress


