
The EdLink 360 school system focus group will center on planning and implementation of EdLink at the system level. EdLink 360 goes live in August.





EdLink 360 File Processing Dashboards

- File extracts should be uploaded to the EdLink FTP server daily, no later than 7:00pm
- Files are processed and results are available in EdLink 360 by 7:00am the following morning
- EdLink 360 file processing dashboards are available for verifying the results which may include:
 - file rejection errors errors that prevent the file from being processed
 - e.g. invalid file signature, invalid file name, required columns missing, etc.
 - file record rejection errors errors that prevent the record from being loaded to the data warehouse
 - e.g. data type mismatch, duplicate records, data exceeds defined column length, etc.
 build audit errors errors that occur when data is loaded to the warehouse but it does not align with business rules to connect it to other data and populate all fields correctly
 - e.g. invalid dates, codes, keys, etc.
- In Progress: We are currently reviewing the error messages that are displayed during file processing to improve readability and to provide a clearer explanation of what corrective action should be taken (e.g. addition of error codes, rewording/reformatting error messages,




EdLink 360 Reporting Dashboard Pilot

- In March, we would like to release a set of reporting dashboards for feedback
 - <u>Purpose</u>: To allow data managers early access to a set of reporting dashboards that will eventually be released the field; to provide feedback on the functionality and usefulness of those dashboards; to ensure LEA data needs are met with the data
- Proposed Reporting Dashboards
 - School System Info School Directory & School Profile
 - Enrollment Overview Current and Year over Year enrollment, overall and by various subgroups
- These dashboards will be pushed to EdLink and available in the waffle under "Essentials"

CVR Verification Flags - Update

- <u>Problem</u>: CVR is going away with EdLink. Two flags were previously added to the *staff_course_offering_link_ext.tsv* extract to identify teacher & principal roster verification.
 - Vendors will no longer be required to send the flags represented by fields TEACHER_CLASS_ROSTER_REVIEW and PRINCIPAL_CLASS_ROSTER_REVIEW
- <u>Solution</u>: LDOE will develop a dashboard with course/student rosters to verify, similar to the current CVR portal – April 2022 implementation
 - Teachers & Principals can log in to EdLink & view rosters
 - Verification window will be established, and teacher/principal will need to work with data manager to make class schedule updates as needed
 - Usage & Statistics dashboard will be developed to identify which teachers & leaders are visiting the verification portal.

EdLink Security – State User ID

- There is a State User ID field in the eScholar StaffID template which must be maintained in order for EdLink security to work properly.
- It has been mentioned by data managers and vendors that it would be a heavy lift to have to maintain this field for all users in your school system who are approved to access EdLink 360.
